
The Keysight E8257DV01-V15, V1B and V2B Signal Generator Frequency Extension (SGX) Modules are manufactured by Virginia Diodes, Inc. (VDI). The Amplifier/Multiplier Chain (AMC) modules may be used with the Keysight E8257D PSG Signal Generator.

These SGX modules provide high performance frequency extension of microwave sources into the THz range. These modules combine high test-port power with low phase noise to offer exceptional performance. Refer to the VDI User's Guide included on the USB drive.

To set your PSG to be used with the SGX module, set the frequency multiplier value in the PSG to match the N=x value printed on the label on the top of the SGX.

[Frequency] > More > Freq Multiplier > [N] > X (see label on SGX for N value)

By doing this, the PSG will display the frequency that is at the output of the SGX module.

NOTE

Always use the information printed on the SGX label of your module.

- When using the RF (L) Input (typical connection), use RF (L): N= X, with "X" being the multiplication factor value shown on your SGX label.
- When using the RF (H) Input (jumper removed), use RF (H): N= X, with "X" being the multiplication factor value shown on your SGX label.





On the SGX label, the multiplication factor values are circled. This is an example only; the actual values will vary.

Power Requirements

- Voltage and/or range (V): 100-240 Vac (AC input for AC/DC adapter), 9 Vdc (input for module)
- Frequency and/or range (Hz): 50-60 Hz (AC input for AC/DC adapter)
- Power in Watts, VA or Current (A): 1.2 A max (input for AC/DC adapter), 4 A (input for module)

NOTE

The instrument can operate with mains supply voltage fluctuations up to \pm 10% of the nominal voltage.

Install the instrument so that the detachable power cord is readily identifiable and is easily reached by the operator. The detachable power cord is the instrument disconnecting device. It disconnects the mains circuits from the mains supply before other parts of the instrument.
